PARK CLOSURE AT DUSK

B. Lovett reported that the police are concerned with the rise in unusual activity in the City's Robertson Park after dark as of late. In an effort to quell the activity the City manager within his authority is going to close all city parks during non-daylight hours until further notice, any activity in parks during non-daylight hours will be deemed to be a violation of the City's Local Ordinance No. 14. It is the hope that this is a temporary measure.

B. Lovett reported that there has been an increase in temporary box storage containers on some City parcels that have remained for extended periods of time. It is his recommendation that the City implement a local ordinance that would layout rules for such storage containers.
