From the City Manager

As everyone has heard by now, the City of Sherrill like many other communities across the State of New York, found many of its programs, events and facilities closed or cancelled due to COVID-19 and the limitations imposed by the Governor's executive orders. In addition, the City is preparing for the fiscal impact related to COVID and is projecting a significant reduction of revenues. In late May the City of Sherrill Commission proactively made some very difficult decisions related to the 2020 Sherrill City Budget. The decision to close the pool, furlough employees and cut partial funding to community assets was not taken lightly. Thankfully many of our local businesses and individuals who donate towards our annual programs and events have asked us to keep their donations to be used towards community events and programs. The City has explored and planned some creative ways to keep the Community engaged over the summer and throughout the rest of 2020. Please follow the City's Facebook page for information about upcoming events and programs that are allowed under the phased reopening that follow New York State rules and regulations.

As of June 24, 2020, Refuse/Recycling collection (Wednesday & Friday) by City crews has been moved to 6am, which is 1 hour earlier than in the past. Residents may still place their cans out to the curb after 6pm the night before their collection day. The City will transition to third party collection in late fall. The City Commission awarded Bliss Environmental Services a 3-year collection contract in May. At this time there are no additional changes that will affect current collection. Additional information and details about the third-party collection will be available closer to the transition date.

The Sherrill Power & Light Department has successfully completed the necessary repairs to the North Main substation. This work included the replacement of broken glass insulators which were part of the 115KV ground

operated air brake switch. Damage to the insulators was discovered during the department's routine substation inspections earlier this year. While this maintenance work led to two small City-wide outages in late May and early June, the crew surpassed expectations and had the City back online well before the anticipated restore time. The Sherrill Power and Light crews' attention to detail and maintenance prevented a catastrophic failure which would have caused a significant and delayed power outage.

Fireworks have been a cause of concern lately amongst several communities including ours. Residents are reminded that fireworks, including firecrackers, bottle rockets, roman candles, spinners and aerial devices, remain illegal statewide, even though you may be able to purchase these in the state. Sparkling devices which include sparklers, snakes, poppers, and fountains are the only legal fireworks that can be used by residents.

We encourage everyone to follow the City's Facebook page for announcements and to stay up to date with what's happening. The City email list is also a great way to stay connected. If you haven't already, please visit the City website to register. Police Department Reminders

-Residents are reminded that most fireworks are illegal in NYS. Sparkling devices which include sparklers, snakes, poppers, and fountains are available to purchase in many counties across the state. It's only the second year these kinds have been legal. However, *all other types of consumer fireworks, including firecrackers, bottle rockets, roman candles, spinners and aerial devices, remain illegal statewide.*

-Quiet hours are 10pm-7am.

-Residents who are going away can schedule a security check with the department.

-Please be aware of scams. Do not give out information unless you can verify the request.

-Please license and pick up after your dogs & honor leash laws.

-Always keep car doors locked, especially at night.

-Please be aware of pedestrians and bicycles. Pedestrians are encouraged to wear reflective clothing and use reflective gear for pets after dark. At night bikes must have lights.

-Children under 14 are required to wear a helmet when biking or rollerblading.

City Hall is open to the public again. Masks are required to enter the building and proper social distancing measures need to be adhered to. Employees are sanitizing areas of public contact.

Summer Sun Safety

It only takes 15 minutes for sun to damage skin. Ultraviolet rays can lead to severe sunburns which can increase the risk of skin cancer. Each year, nearly 4,000 New Yorkers are diagnosed with Melanoma. The city has partnered with the Oneida County Health Dept's Cancer Prevention in Action Program to help the community stay safe. Here are some easy ways to stay protected from the sun:

- Cover Up! Long-sleeved shirts and long pants help block UV rays from reaching your skin and a wide-brimmed hat can give your face, neck, ears, and head protection.

- Wear sunglasses, even on cloudy days. This can help prevent cataracts from developing in the future.

- Apply broad-spectrum sunscreen with SPF 15 or higher before going outside and reapply every 2 hours.

- Keep your lips protected by applying a lip-balm with SPF15.

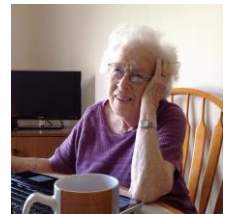

-Like so many other entities, the library has been affected by COVID-19. The grant funded capital improvement projects to replace and update the roof, windows, restrooms, etc. have been delayed, the Summer Reading Program has been cancelled, the May Spring for Books fundraiser has been rescheduled as a smaller event and the Friends of the Library Used Book Sale has been cancelled. City of Sherrill budget cuts, which eliminated the city's third and fourth quarter funding, led the library to need to reduce hours, staff and material expenses. The library is committed to its mission to meet "the educational, cultural, recreational and informational needs of the community" and is working to reconfigure the library's services to meet new safety regulations and work with reduced financial resources. The library is required by New York State to be open 25 hours a week. The current hours, which may change, are Monday-Friday, 11am-4pm.

-Curbside service started June 15. Materials owned by the Sherrill Kenwood Library only are available for checkout as MidYork is not transporting materials between libraries at this time. Requests can be made online at www.midYork.org or by calling the library during business hours. Library materials must be quarantined for 72 hours between checkouts so this may result in longer wait times. Please limit requests for newly released books to 2. Not sure what to read? Let the library put together a book bundle for you! Call the library with your choice of author or subject and we'll pick some of our favorites! We can include books, audiobooks and DVDs and can make kids and adult book bundles!

-2020 marks the 50th anniversary of the library's current building location and we are still planning to celebrate this milestone! The library is in the process of planning this celebration, additional programs and offering to-go craft kits in accordance with health department guidelines. Stay tuned for details.

-Fax and copy services are available! Call to schedule a convenient time!

-Fines are waived until further notice.



-The Friends of the Library group is selling tote bags for \$5. These can be picked up during curbside service.

-The group purchased admission passes to local parks and venues and these passes are available to borrow for use at NYS Parks, Onondaga County Parks, the Rosamond Gifford Zoo & The Everson Museum of Art.

Typically, SFB adds around 200 books to the library's collection. Unfortunately, we had to cancel the official May event, but we have rescheduled on a smaller scale for Friday July 24. Brush & Green Waste Reminders- Limbs must be less than 6' long and 4" wide and be placed parallel to the curb. Piles must be free of garbage, soil, rocks, animal waste, etc., and not be placed in any type of bag, etc. Contractors must obtain a permit from City Hall to drop off brush or green waste from residents or businesses.

Recycling- The following items cannot be recycled:

Clothes hangers	Pizza boxes with food
Copy paper wrapping	Plates and tableware
Frozen food cartons	Plastic bags
Furniture	Plastic silverware
Light fixtures	Plastic packaging
Metal hanging file folders	Plexi-glass
Metals	Six-pack holders
Motor oil bottles	Snack bags
Napkins & paper towels	Straws
Paper cups & plates	Styrofoam
Pesticides	Toys
	Prescription bottles

-Needles/Syringes must be placed in a puncture proof container and then taped closed, labeled as sharps, and placed in the garbage.

-Please clean recycled cans and bottles.

-Cardboard must be broken down into no larger than 3'x3' squares & not folded or placed in other boxes.

-Items that cannot be recycled will not be picked up.

Compost- is available for residents at the end of Fairway Lane, next to the WWTP.

Transfer Station Hours- Saturdays 8am-1pm year-round and Wednesdays 4-7pm until early fall, for Sherrill residents. Residents may purchase coupons at City Hall, or due to COVID-19, residents may write a check, payable to the City of Sherrill, for items they drop off. Please note- checks will only be accepted during this temporary time. ID/proof of Sherrill residency will be required to drop off items.

Shredding & Plastics Collection, Saturday July 18, 8-10am- Sherrill residents are invited to bring paper, folders and envelopes they need shredded to the Transfer Station at 210 Elmwood Place, for this free event. Residents may also drop off bulky rigid plastic items to be recycled, at no charge. Photo ID/proof of Sherrill residency will be required.

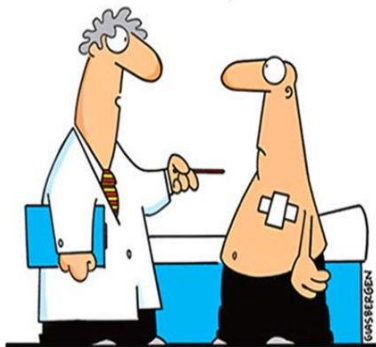
