CIVIL SERVICE JOB CLASSIFICATION

The City of Sherrill Civil Service officer oversees the City of Sherrill appointments as well as the VVS School District. VVS is amending the classification for Groundskeeper/Cleaner. The City Commission as authorizing board needs to adopt the classification. A public hearing was held on Wednesday, March 23, 2022, by the Civil Service officer. No members of the public commented or were present. A motion as made by D. Hyle and seconded by P. Hubbard to approve the amended Groundskeeper/Cleaner classification.

SURPLUS PROPERTY – OLD DUMPSTERS

B. Lovett reported that the City has some old 3 yd. dumpsters that are no longer good, except for scrap value. Lovett would like to try and sell them and if they do not sell, then scrap them. Motion was made by D. Hyle and seconded by P. Hubbard to declare the dumpsters as surplus property and authorized their sale or scrapping.

POWERLINE EASEMENT

B. Lovett reported that the underground electric project to replace the overhead compromised lines that run behind the four or five Skinner Road residents has hit a snag in that one resident is refusing to authorize a utility easement for the City. The City is looking at all alternatives including overhead in front of the houses, potentially using the already established City of Oneida sewer easement, which is in the correct location or potentially just by passing the uncooperative neighbor, Patrick Fowler, and utilizing the other neighbors already approved easements. IF the City was to bypass Mr. Fowler, his service would remain overhead, and the lines would be basically abandoned by the City and up to him to maintain. A word on the possibility of utilizing the City of Oneida easement should be forthcoming. Fowler is looking to allow the easement for \$1,250. When all other easements were and are obtained for \$1.00. This is not an option for the City.

Mr. Fowler was present at the meeting and gave a version of the easement dilemma that was less than accurate. Mr. Fowler claimed he never had an issue with allowing the City into the City of Oneida easement to complete its work, but there was a reason a different path and easement needed to be drawn up. After additional discussion Mr. Fowler agreed that if the City could not work in the City of Oneida easement (which he had no problem with) he would back off his request for \$1,250 and sign the easement in return for the removal of one dead tree that is on the property line adjacent to the powerlines, that the Sherrill P&L already trimmed up to keep from the overhead lines. It was left that the City would report back to Fowler if they could not work within the current City of Oneida easement and pursue the easement for the one tree removal. If they could work in the City of Oneida easement then they will take that approach.

Motion was made by D. Hyle and seconded by P. Hubbard to adjourn.
