PUBLIC INPUT SESSIONS  
ROUTE 5 CORRIDOR SIDEWALK PROJECT

Mayor Vineall opened the public input session at 7:15 p.m. there were 6-8 members of the public present, none of whom commented or questioned the proposed project. Chris Maybe from Delta Engineering led a presentation on the proposed project. The City was awarded a New York State Transportation Alternatives Program (TAP) Grant for pedestrian safety. The project is to construct a sidewalk along the south side of Route 5 connecting Betsinger Road and Sherrill Road. Additionally, there would be some additional proposed work at or near both intersections of Route 5. The grant is an 80-20 matching funds grant. The City is responsible for 20% and it is the City's intension to use a portion of the ARP funds it received along with some Oneida County funding that has been committed as it's portion. The NYS DOT is still reviewing the proposed project design and hopes to have their comments completed by late next week. There being no further comments, the mayor closed the public hearing, more information will be available as the project progresses. It would be slated for 2023 build.
