FORMER ALASKAN OIL PROPERTY

B. Lovett reported that the contractor for the DEC is almost complete with the cleanup of the contaminated property on Route 5 that the City owns from tax foreclosure. The City is still waiting for word from the DEC on the next steps for the disposal of the property. The agreement with the State and DEC was that the City had to sell the property to get in back on the tax roll and that the proceeds would be split with the DEC/State of New York. Ultimately the Commission will authorize its sale.
