# REGULAR MEETING July 10, 2023

### **ROUTE 5 PROJECT**

B. Lovett gave an update on the Route 5 sidewalk project that the City obtained a grant for over a year ago. The State DOT has finally gotten the project specifications almost complete, but with our engineer's recommendation getting the project bid and constructed by the fall would be very tight at best, so he suggested bidding in winter with a first thing in the Spring construction. The City Commission concurred.

## UTV AND GOLF CART COMPLAINTS

B. Lovett reported that the City has not typically addressed the few golf carts that traverse the city streets to the golf course. By letter of the law, New York State Vehicle and Traffic Law 2403, it prohibits the use of ATV's, UTV's and golf carts on public highways (city streets). There has been an increase in vehicles as well as a number of complaints about UTV's and to a lesser extent golf carts. The City cannot selectively enforce against either of these vehicles, nor can it create local legislation to allow under certain criteria. Thus, the City Commission directed the City Manager and police department to start the enforcement of NYS Vehicle and Traffic law in regard to section 2403. Lovett will coordinate a statement for release with the police chief and the city attorney.

# SALE OF SURPLUS PROPERTY – P&L PICK-UP TRUCK

Lovett reported that the auction for the pick-up ends tomorrow, but the price is already up to \$21,400. When the auction closes the buyer needs to be approved and the next meeting is not until July 31<sup>st</sup>, the price is already at the expected sale price. Motion was made by J. Shay and seconded by P. Hubbard to authorize the City Manager to award the sale after the auction closes on July 11, 2023.
