RATE STUDY - ELECTRIC

GOLF CARTS ON STREET PROHIBITION

Jack Stone, 841 W. Hamilton Ave., addressed the City Commission regarding their stance at last meeting to enforce New York State Vehicle & Traffic Law, which prohibits ATV and golf carts from being driven on city streets. The City has in essence not enforced the law previously. Mr. Stone asked if the City would just allow golf carts that were traveling exclusively from a home to the golf course to still be allowed. The Commission sympathized but said as concurred by the City attorney that they could not selectively enforce the law that way.

2024 5K ROAD RACE

Linda Evans and Gina Geroux addressed the Commission with a presentation to ask to be able to hold a 5K road race next year on the Saturday of fireworks weekend. They said they would cover all costs. The City was basically supportive but B. Lovett would meet with the police chief regarding the logistics and would get back to Linda prior to next meeting on August 21, 2023.

SALE OF SURPLUS PROPERTY – 2019 P&L PICK-UP TRUCK

Lovett reported that the two pick-ups have finally arrived, and the 2019 pick-up currently being used by the parks department is now surplus. Motion was made by J. Shay and seconded by T. Dixon to declare the pick-up surplus and put it for sale on Auctions International.
