AUTHORIZE RENEWAL OF INCREMENTAL POWER CONTRACT

M. Holmes reported that the City's agreement with the New York Power Authority (NYPA) to purchase incremental power on behalf of the City expires 12/31/2023. The new proposed contract to purchase incremental power for the City once we exceed our hydro power allotment. The new contract will run through December 3, 2026. Motion was made by D. Hyle and seconded by P. Hubbard to authorize the City Comptroller to execute.
