ROUTE 5 SIDEWALK PROJECT

B. Lovett reported that the New York State DOT has signed off and gave their approval for the city to bid the Route 5 project. The following bids were received for the project:

The City has earmarked the balance of its ARPA funds \$150,000. Additionally, the City was awarded \$800,000, in the form of a grant for the project and has been promised additional funds from Oneida County to help pay for the project. Motion was made by K. EQUIPMENT RESERVE FUND EXPENDITURES

M. Holmes reported that in January when the Equipment Reserve Fund Expenditure resolution was passed it was correct referring to \$265,000. However, the legal notice that went in the official newspaper had a typo of \$65,000. Holmes asked the commission for consideration in passing the resolution again so that the legal notice could reflect the proper not to exceed amount, \$265,000 for the new sweeper.

Motion was made by J. Shay and seconded by C. Niles to accept the following resolution:

RESOLUTION AUTHORIZING THE CITY COMPTROLLER TO EXPEND FUNDS FROM THE CITY'S EQUIPMENT RESERVE FUND, SUBJECT TO A PERMISSIVE REFERENDUM

The City Commission of the City of Sherrill, duly convened in regular session, does hereby resolve, pursuant to the provisions of Section 6-c of the General Municipal Law that the City Comptroller of said city be, and he hereby is, authorized and directed to transfer and expend from the Equipment Reserve Fund of said city, duly establish on March 23, 1981, (a) a sum not to exceed \$265,000 of the principal and accumulated interest in said fund for a street sweeper based on specifications prepared therefore by the City Manager.

This resolution shall be subject to a permissive referendum, as permitted by law.
